The quotation will be open on 20/03/2025 at 3:00 PM at Conference Hall of ADO Office situated at Garukhuti Bahumukhi Krishi Prakalpa in presence of quotationers or their authorized representatives who wish to attend the opening of quotations.

Terms & Conditions

1. The quotationers must mention their complete postal address with their PIN No., Phone No. etc. in their quotation
2. No transportation cost will be provided for lifting of goods, all transportation cost to be borne by the supplier itself
3. Rate of items should not be more than MRP
4. Items have to be delivered at the Office/Store of Garukhuti Bahumukhi Krishi Prakalpa Samiti and item delivery challan copies have to be signed by the competent authority / recipient.
5. The items should be supplied as when required and on urgency basis as well.
6. Quality of items has to be good. The working committee, GBKPS has right to reject goods of inferior quality.
7. All tax has to be paid by concerned supplier.
